III. COMMITTEE REPORTS/CORRESPONDENCE TO THE BOARD

A. Report of Student Representatives

Miss Smalley reported on the New England Association of Schools and Colleges (NEASC) visit; the Berlin High School Drama Club performed *Up the Down Staircase*; the Berlin High School winter choral concert will be held on December 4, 2018; the Music Department and UpBeat are selling poinsettias; the football team plays in the State M quarterfinal tomorrow; winter sports have begun; Berlin High School was recognized as a CIAC Michaels Cup "Class Act" Sportsmanship recipient; and the National Honor Society induction ceremony will be held on November 29, 2018.

A. Superintendent's CAPSS (Connecticut Association of Public School Superintendents) Student Awards

The administration and staff selected ten students to receive the Connecticut Association of Public School Superintendents (CAPSS) Superintendent/Student Award Recognition Program, "Certificate of Excellence" award. Students are selected for this prestigious annual award based upon criteria such as demonstrated leadership to the school community, community service and service to others, and academic prowess relative to ability. Building Principals and Superintendent Benigni presented the CAPSS awards this year to fifth graders Janalyn Weber and Ryan Lavender (absent) from Griswold School; Meghan Snyder and Paolo Cultrera from Hubbard School; and Sandra Carminati and Matteo Modifica from Willard School. IX. NEW BUSINESS

A. Facilities Related Updates

Director of Business Operations Jeffrey Cugno reported on his meeting with Doug Solak this date. Mr. Cugno reported the manufacturers and engineers have determined the valve sizes and functions within the system are the cause of the air conditioning issues. Mr. Cugno reported the recommended solution for the duct work is to jacket the duct work to protect and seal the system. A change order will be created and will ask the State for additional funding. Mr. Cugno reported he continues to request from the Public Building Commission status reports for the Berlin High School so the Board can do their due diligence before accepting the project.

Mr. Cugno reported work is being done on the entrance ramps at McGee Middle School to comply with the Americans with Disabilities Act (ADA) requirements; improvements are being made to the walkway at Willard; and the football field will be reseeded in the spring.

B. Policy Review/Revision – Policy 5141 – Wellness – First Reading

Revisions have been made to this policy based on an evaluation of the policy by the Connecticut State Department of Education as part of the local school wellness policy review process. Revisions reflect new requirements updating the Healthy, Hunger-Free Kids Act of 2010. This policy was reviewed by the Ad-Hoc Committee for Policy Review/Revision at their meeting earlier this evening. Since this is a first reading, no action is required; the second reading/approval will take place at the December 10 meeting.

C. Ratification of Contract – Teachers (executive session anticipated)

Negotiations with the Berlin Education Association (teachers) were recently completed and a tentative agreement was reached. It is recommended that the Board approve the tentative agreement.
