PRIOR TO MOVE IN RESIDENCY AFFIDAVIT INSTRUCTIONS

(Requesting permission to Enroll Student Prior to Move-In Date)

- A Tuition Waiver may be granted if the family is buying/building/renting a home and it will not be ready prior to enrollment. The attached Residency Affidavit will need to be completed in front of a notary, notarized, and approved by the superintendent in order to be valid.
- The family must take occupancy of the home within 90 days from the date the notarized form is submitted and approved.
- In lieu of proof of residency paperwork, the parent/guardian(s) must provide one of the following:
- o loan commitment letter with a closing date that is within three months of affidavit submission
- o copy of a certificate of occupancy showing that the home will be habitable within three months of affidavit submission
- lease with an occupancy date that will be valid within three months of affidavit submission.
- If building has not begun, residency cannot be granted.
- The parent/guardian(s) will be responsible for the student's transportation until the family takes occupancy of the home.
- A copy of the closing documents will need to be provided once the family moves into the home, along with a utility bill or request for service verification letter.
- All Residency Affidavits are reviewed by Berlin Registration Personnel and sent to the Superintendent of Schools for final approval. For questions, please contact Margarita Alahverdian by phone at 860-828-6582 or by email at malahverdian@berlinschools.org.
