Dear Parents and Community Members:

The Connecticut Travel Advisory has been updated to reflect changes in the CDC recommendations related to quarantine requirements for those who have tested positive for COVID-19. We are updating our Berlin Public Schools Travel Protocol to reflect those edits.

FOR YOUR OWN PERSONAL SAFETY, WE STRONGLY ADVISE YOU NOT TO TRAVEL AT THE CURRENT TIME. IF TRAVEL IS UNAVOIDABLE, YOU ARE REQUIRED TO ALERT THE <u>SCHOOL NURSE</u> IN ADVANCE OF YOUR DEPARTURE, TO DOCUMENT YOUR DESTINATION AND TRAVEL DATES.

In consultation with the Central CT Health District, we have developed the following mandates which apply to travel:

- · If you have traveled into an identified state or country that requires you to quarantine for ten (10) days upon return to Connecticut; and you wish to take the RT-PCR test in order to reduce the quarantine period to seven (7) days to return to school earlier (A rapid antigen test or an antibody test will not satisfy the state's exception to the quarantine requirement); then you must wait five days after returning to Connecticut before getting the RT-PCR test. The purpose of this five-day period is to allow any potential virus infection to incubate and aid in a more accurate test result. If this test is negative, you must provide a copy of the negative RT-PCR test result prior to returning to school.
- A person who has tested positive for COVID-19 within ninety (90) days prior to travel and who has clinically recovered, or who has not been symptomatic for a period of ten (10) days since symptom onset or positive test date, if not symptomatic, is not required to self-quarantine upon return, provided such person submits appropriate documentation prior to travel.
- At the present time, travelers who have been vaccinated against COVID-19 are still subject to the quarantine requirements of the state as well as the district protocols set forth above in paragraph one.

Travel increases your chance of contracting and spreading COVID-19. Staying home and practicing social distancing, wearing appropriate face coverings and diligent hand washing is the best way to protect yourself and others.
