I. CALL TO ORDER

Mr. Tencza called the meeting to order at 6:03 p.m. in the Dr. Robert P. Long auditorium at Berlin High School, 139 Patterson Way, Berlin, Connecticut. The Pledge of Allegiance was recited.

III. COMMITTEE REPORTS/CORRESPONDENCE TO THE BOARD

A. Report of Student Representatives

Mr. McGowan reported callbacks for the school musical *Les Miserables* were held today after school, and the cast list will be announced Wednesday; fall sports are winding down with football still competing; and tryouts for winter sports begin soon. Mr. McGowan provided a listing of new clubs at the high school.

Ms. Smalley reported the National Honor Society induction ceremony was held last week with an additional thirteen senior members inducted; tonight the Powder Puff Football game will be held at Sage Park in memory of Tyler Cop and Nick Zuk and to support Berlin Helping Berlin; and the Upbeat fall weekend was held this past weekend at Camp Woodstock, in Woodstock, Connecticut with approximately eighty students attending.

A. Certificate of Appreciation Award to Former Board Member Jake Fisher

Mr. Tencza recognized and thanked former Board member Jake Fisher for his service to the Berlin Board of Education.

B. Superintendent's CAPSS (Connecticut Association of Public School Superintendents)
Student Awards

The administration and staff have selected ten students to receive the Connecticut Association of Public School Superintendents (CAPSS) Superintendent/Student Award Recognition Program, "Certificate of Excellence" award. Students are selected for this prestigious annual award based upon criteria such as demonstrated leadership to the school community, community service and service to others, and academic prowess relative to ability. VIII. NEW BUSINESS

A. Facilities Related Updates

Director of Business Operations Jeffrey Cugno reported the third round of the security grant has been revised as the needs of the district have changed since the application was made two and one half years ago. There is approximately \$400,000 remaining, which will be used for cameras, communications, access card readers, window film and police responders. Mr. Cugno reported he met with a Director of the Security Program for the State of Connecticut this past week and reviewed these plans with him. Mr. Cugno indicated the Director was very receptive, and he anticipates approval to move forward. Mr. Cugno reported the BLAST classroom is moving forward and funds remain for furniture. Mr. Cugno reported the McGee gym will be painted and the Willard gym floor will be refinished over the Christmas break.

At this time Item VIII.E. was moved up in the agenda. Hearing no objection, this item was addressed.

E. Berlin High School Renovation Project – Closeout Status Report

Director of Business Operations Jeffrey Cugno reported he met with Finance Director Kevin Delaney, Tom Smith from Gilbane Building Company, along with the construction manager, architect and engineer, and all issues that were unsettled for a number of months are now settled. Mr. Cugno reported there appears to be in excess of \$1 million remaining from the project, and at this point, the Public Building Commission seems comfortable with the fact that they have completed the project and are ready to return the excess money to the Town. In order to close out the entire project, the Board of Education has to accept it. Mr. Cugno recommended the Board of Education meet with the Town Council to discuss its plans.

Mr. Tencza questioned whether the issue, relative to the ductwork, has been address. Mr. Cugno responded the best information he has is, other than the duct work being painted with a paint sealer that was done after the initial construction was put in place, nothing else has been done. Mr. Cugno

indicated this should not be accepted as there are concerns the duct work will continue to leak and not be able to withstand the weather. The cost to rewrap the duct work, in a manner that has been designed already, is estimated to be \$1.3 to \$1.4 million. This would not be reimbursable from the State of Connecticut.

Mr. Salina suggested, if anything is to be done legislatively next year, the Public Building Commission, in conjunction with Mr. Cugno, should put together a list of all close out items and punch list items that need to be resolved in order to close out the project.

In response to Mr. Aroian's question if the Public Building Commission has made any statement that they believe the project should be closed out, Mr. Cugno responded he is not aware.

Mr. Cugno recommended the Board get involved now to publicly support its expectations and recommended the Board authorize Superintendent Benigni to speak with the Town Council to discuss procedures.

- B. Policy Review/Revision First Reading
 - 1. New Policy #1161 Armed Security Officers

Pursuant to the Board, in support of the hiring of armed security officers for the schools, a new policy has been developed and is proposed for adoption regarding the officers providing support to the administration and staff in maintaining a safe school environment, as well as carrying of firearms on school grounds in the performance of their duties. Since this is a first reading, no action is required; the second reading/adoption will take place at the December 9, 2019 Board meeting.

2 Revised Policy #9085 – Time, Place and Notice of Meetings

This policy needs to be revised to reflect the change in the time that Board of Education meetings begin. Since this is a first reading, no action is required; the second reading/adoption will take place at the December 9, 2019 Board meeting.

- C. Policy Review/Revision Second Reading/Adoption
 - 1. New Policy #0100 BOE Mission Statement/Purpose
 - 2. Revised Policy #9001 Committees

A second reading of new Policy #0100 and revised Policy #9001 took place. At the September 23, 2019 special meeting, the BOE Mission Statement/Purpose was revised and changes were made to Policy #9001 – Committees. A first reading took place at the Board meeting on October 15, 2019.

Ms. Dennis inquired, before the Board makes a motion to adopt new Policy #0100, are there time constraints and does the policy have to be adopted tonight. Ms. Dennis believes the policy is very wordy, and she does not like how the mission statement reads with the words broad opportunities and freedom. She would also like to include the new Board member once appointed.

D. Authorization to Apply and Sign for Credit Cards through the CTDAS P-Card Program

The P-Card Program is a credit card program co-sponsored by the Department of Administrative Services Procurement Division and the Office of the State Comptroller Accounts Payable Division. The P-Card is a commercial MasterCard issued by JPMorgan Chase Bank. It works just like a personal credit card, but it has custom designed features and built-in controls to meet the specific needs of the cardholder and state agency, municipality, public school or non-profit organization.

Moved by Mr. Salina, seconded by Mr. Oakes, to authorize the superintendent of schools to apply and sign for credit cards through the CTDAS P-Card Program.

In response to Mr. Salina's question as to how many credit cards will be issued, Superintendent Benigni responded there will be one card for each school and for cabinet members of the Board, and there will be oversight.
