# II. SPECIAL STUDENT PRESENTATION – BERLIN HIGH SCHOOL MADRIGAL SINGERS

The Berlin High School Madrigal Singers perform under the direction of Tyler Boyle, Berlin High School music teacher. They have earned both silver and gold awards at music festival competitions and perform in period costumes. The group is chosen by audition and features many of the most talented young vocalists from Berlin High School. This year, due to COVID-19, the entire group was not able to perform at tonight's meeting. Singers Meredith Gendreau and Emily Roche each performed a solo.

A. Report of Student Representatives

# VI. NEW BUSINESS

A. Facilities Related Updates

Director of Business Operations Jeffrey Cugno stated the duct work at Berlin High School and the commissioning and balancing study of the HVAC systems in the five schools is moving forward and should be completed by the end of December.

B. Berlin High School Program of Studies for 2021-2022

Assistant Superintendent Erin McGurk and Berlin High School Principal Eileen Eustis presented to the Board of Education, for its consideration and approval, new course offerings and changes to the Berlin High School Program of Studies for 2021-2022. They highlighted the rationale for the changes. An overview of significant changes made to the Program of Studies and a draft copy of the Berlin High School Program of Studies for 2021-2022 were provided to Board members. The changes were reviewed and discussed by the Curriculum Committee at its meeting on October 13, 2020.

Moved by Mr. Salina, seconded by Mr. Pruzin, to approve the new course offerings and revisions to the Berlin High School Program of Studies for 2021-2022, as presented.

C. Motion for Annual Schedule of Regular Meetings

At the November meeting, the Board discussed changing from two meetings to one meeting a month. Moved by Mr. Salina, seconded by Dr. Sassu, to approve the Annual Schedule of Regular Meetings as presented in Option 2 – having one meeting per month with meeting dates generally being held on the second Monday of each month.

Mr. Salina noted the difference between Option 1 and Option 2 is six meetings, and stated he believes the Board can accomplish its business in one meeting a month; however, if a second meeting is needed, a Special Meeting can be scheduled.

Mr. Oakes stated, in the event a Special Meeting is scheduled, careful thought and planning will need to occur as no other business, other than what is stated in the agenda, can occur during the Special Meeting.

D. Revision to the 2020-2021 School Calendar

Superintendent Benigni stated, as COVID-19 cases across Connecticut and here in Berlin continue to rise, the district is revising some of its plans and procedures to help maintain a safe and effective learning environment for students and staff. The district knows that social interactions and contacts of many students will be expanded as families gather for the holidays. Because the emergence of COVID-19 symptoms can take several days after exposure to develop, Superintendent Benigni proposed adjusting the school schedule to operate on a fully remote model for one week after the winter break, January 4-8, 2021. The possibility of this change was discussed at the November 23 meeting. Board members were provided with a revised calendar reflecting the revision. Superintendent Benigni stated Group A will return on January 11, 2021.

Moved by Mr. Salina, seconded by Mr. Jenkins, to approve the revision to the 2020-2021 School Calendar, as presented.
