A. Report of Student Representatives

VIII. NEW BUSINESS

A. Status of the Board of Education's Adopted Budget for 2021-2022

Assistant Superintendent Erin McGurk stated on February 8, 2021, the Board of Education adopted an Operating Budget for the 2021-2022 fiscal year in the amount of \$48,534,130. Following review from the Board of Finance, the Operating Budget was cut \$648,498. The annual town budget referendum will be held tomorrow, and the proposed budget, submitted by the Board of Finance and Town Council, for the town and schools is \$93,959,047. The Board of Education's share is \$47,885,632, which represents a 3.17% increase.

Mr. Salina stated there is no tax increase being presented and all services are maintained.

B. Non-renewal of Contracts for Non-tenured Staff

Assistant Superintendent Erin McGurk recommended the non-renewal of contracts of employment for the following non-tenured staff who were hired for a one-year assignment or as a long-term substitute: Brittany Coco, Shannon Gottsman, Jennifer Sullo and Sanja Trifone.

Moved by Dr. Sassu, seconded by Mr. Oakes, that the contracts of employment for the following non-tenured teachers not be renewed for the 2021-2022 school year, upon their expiration at the end of the current school year: Brittany Coco, Shannon Gottsman, Jennifer Sullo and Sanja Trifone.

C. State Healthy Food Certification Statement for July 1, 2021 through June 30, 2022

Section 10-215f of the Connecticut General Statutes requires that all Connecticut public school districts that are eligible to participate in the healthy food certification take action to certify whether all food items sold to students will or will not meet the Connecticut Nutrition Standards published pursuant to Section 10-21e of the Connecticut General Statutes for the period of July 1, 2021 through June 30, 2022, and whether to allow food and beverage exemptions.

Moved by Mr. Salina, seconded by Mr. Pruzin, that the Berlin Board of Education will participate in the optional Healthy Foods Certification Program, pursuant to C.G.S.

Section 10-215f, for the period of July 1, 2021 through June 30, 2022, and certify that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to school stores, vending machines, school cafeterias, culinary programs, and any fundraising activities on school premises sponsored by the school or non-school organizations and groups. The Board will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards and beverages not listed in Section 10-221q of the Connecticut General Statutes, provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food and beverage items are not sold from a vending machine or school store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held.

In response to Mr. Jenkins' question, is there any impact to fundraising, Ms. Dennis stated no.

D. Facilities Related Updates

Director of Operations Jeffrey Cugno stated the potential closeout of the Berlin High School project will be discussed later in the agenda. Mr. Cugno reported the final report concerning the commissioning and balancing study of the HVAC systems in the five schools has been provided to the Public Building Commission for review, and he anticipates their report shortly as to how they wish to proceed. Mr. Cugno stated the Public Building Commission has decided to commission engineering studies, not only for the HVAC system at Willard School, but also for Griswold School and Hubbard School.

E. Partial Funding Request for Ice Hockey Program

Director of Athletics, Health and Physical Education David Francalangia requested the Board consider allocating \$10,000 each year for costs associated with the Ice Hockey Program to help offset the cost to parents. There are seven BHS players on the co-op roster, and the current cost for each player is \$2,375. Board members were provided with a letter from Mr. Francalangia. The Finance & Operations Committee met on March 30 to discuss the request.

Moved by Mr. Pruzin, seconded by Mr. Weber, to allocate \$10,000 each year, beginning with the 2021-2022 school year, for costs associated with the Ice Hockey Program to help offset the cost to parents.

Mr. Oakes stated the Finance & Operations Committee did meet, about a month ago, and discussed this request. The Committee is in agreement to allocating \$10,000 each year for costs associated with the Ice Hockey Program to help offset the cost to parents and is hopeful, going forward, the Ice Hockey Program can obtain the level of funding other varsity programs receive.

Ms. Dennis stated she is happy this item appeared on tonight's agenda for the students and their families.

Mr. Pruzin noted his support for allocating funds for costs associated with the Ice Hockey Program as he is familiar with the expensive costs, including ice time.

F. BHS Building Project Closeout

Mr. Oakes stated the preliminary estimate for the insulation and jacketing of the duct work was approximately \$300,000; however, information received today puts the estimate at \$1 million. Mr. Oakes stated there needs to be further discussions between the Board of Education, Town Council and Public Building Commission as to why this amount is significantly different from the preliminary estimate. This item will appear on the May 10, 2021 agenda.
